




This chart shows the total general purpose revenue Alpha Cindy Avitia High School expects to receive in the coming year from all sources.



Over the course of the 3-year LCAP, our actions were effectively implemented, helping us make progress toward our goal of enhancing instructional strategies to ensure the curriculum and coursework are accessible for all students. The intentional strategic allocation of funds towards hiring key roles, such as the ELD specialist, and addressing specific student needs, like chromebooks and classroom libraries, has been foundational. Investing in curriculum purchasing and providing comprehensive training for staff on its implementation, coupled with step-back days focused on data analysis, has enabled both a school-wide and individual teacher perspective on performance trends, driving meaningful instructional improvements.

The role of the ELD specialist has been particularly impactful, with a single specialist this year stepping up to fill the gap left by not being able to hire a second specialist as planned. Their involvement has not only been instrumental in testing and compliance but also in leading professional development that equips the entire staff with effective strategies for supporting English Learners directly in the classrooms.

Additionally, the cross-site ELD cohort, facilitating site visits and practice-sharing sessions, has enriched our practices, though the challenge of filling the second ELD specialist role due to a less robust pipeline remains.

Among the challenges we've faced, there is a significant opportunity to further tailor professional development to the varied levels of teacher development and align more closely with our school goals. While the acquisition of books for classroom libraries marks progress, developing a cohesive system for student engagement with these resources is an area for growth. Similarly, while our network-wide professional development is strong, site-specific differentiation in professional development to meet the direct needs of our team members, as informed by our performance data and evaluation rubrics, presents a path for further refinement and impact.

Overall, our actions have laid a solid foundation and generated impactful successes, but they have also illuminated the pathways through which we can evolve and enhance our approach to meet the diverse needs of our school community more effectively.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

Over the past three years, our actions under Goal 1 have demonstrated overall effectiveness in achieving our targets. We have seen notable growth and successes, although some of our three-year objectives were not fully met. One of the significant accomplishments was ensuring that 100% of our students had access to standards-aligned instructional materials and essential technology. This was achieved through the successful implementation and effectiveness of a combination of targeted actions:

- Action 1.2: Purchasing and providing training for high-quality curriculum.
- Action 1.3: Implementing blended learning software and supports.
- Action 1.4: Distributing Chromebooks and hotspots to all students.

We aimed to have 30% of our English Learners (EL) make progress toward proficiency, scoring a 4 on the summative ELPAC assessments. Although we did not meet this target, we achieved a substantial increase, with 50.9% of our EL students making progress, which received a Green performance level as reported on the CA School Dashboard. This represents a 6.9% increase from the previous year and surpasses the state average of 48.7%. We attribute this success to several actions outlined in Goal 1, inclusive of offering differentiated professional development, which equipped teachers with strategies to support EL students more effectively. The ELD specialist played a crucial role in enhancing our English Learners' growth by providing designated instructional support and effective integration of language development strategies into the general curriculum during integrated ELD instruction. Focusing on data during our "data step-back" days, also helped in monitoring and addressing the specific needs of EL students. Despite this progress, we fell short of our reclassification target, with only 7% of our EL students being reclassified, against a goal of 15%. This indicates a need for further refinement and targeted interventions to boost

#### reclassification rates in our next LCAP cycle.

CAHS has adjusted its assessment strategy to shift from STAR to NWEA MAP testing in both Reading and Math. In Math, 47% of students meeting their growth targets on our NWEA assessment, an improvement from 42% the 22-23 school year. Although we narrowly missed our target of 50%, this progress is encouraging and highlights the effectiveness of our instructional strategies and supports. In addition, in NWEA MAP, CAHS students achieved a weighted average conditional growth index score of 1.85. Based on the CDE's guidance on verified data for charter renewals, this positive school CGI score exceeds the target range (-0.2 to 0.2) of a year's growth in Math, which is a positive indicator of progress. Our CAHS NWEA Reading weighted conditional growth index score was 0.74, similarly indicating positive growth for our students. Our NWEA reading scores will serve as a baseline for the next LCAP cycle, and we are optimistic about further advancements as our actions for the next LCAP cycle take effect.

Based on the educator partner feedback and the annual engagement process, there are several pivotal changes to Goal 1 in the upcoming LCAP cycle aimed at improving outcomes for our significant student groups, including English learners, students with disabilities, and low-income students. The decision to update Goal 1 stems from a detailed analysis of lower performance outcomes as indicated by the CA School Dashboard and other local assessments. This analysis highlighted the necessity for a more focused goal to address the specific needs of our subgroups, ensuring alignment across the network and enhancing support and strategic resourcing.

The new Goal 1 will include targeted actions designed to address the unique needs of these groups:

- English Learner and Long Term English Learner Supports
- Students with Disabilities Supports
- Academic Interventionists
- Tier 1 Strategy

To ensure success for our student groups, we will monitor the effectiveness of these Actions by setting aggressive 3-year targets for the following metrics:

- Local Indicator Priority 2 Survey: EL access to CCSS and ELD standards
- ELPI
- Reclassification Rates
- SBAC DFS ELA (student groups)
- SBAC DFS Math (student groups)

These actions and metrics were developed in response to feedback from educational partners and a thorough review of performance data. The changes reflect a strategic shift towards more specialized and direct interventions that are expected to significantly impact the academic success of English learners, students with disabilities, Hispanic, and low-income students. This goal revision aims to not only address the observed performance disparities but also to enhance overall educational equity and access, ensuring that all students have the necessary support to succeed academically.

# **Goal Analysis**

The school has been proactive in allocating funds and hiring specialized roles such as Academic Interventionists (AI) and Associate Teachers (AT) to support targeted student groups. However, vacancies due to mid-year departures of both AIs and ATs presented challenges, though efforts to rehire and fill these positions have been underway.

Emphasizing data Stepback Days, department meetings, and professional development sessions has enabled a focus on subgroups, leading to informed decision-making and strategic rostering for English Language Development (ELD) classes. The introduction of strategic rostering based on ELPAC and NWEA reading scores for ELD classes demonstrates a tailored approach to support ELs. The employment of AIs to bolster EL support and coaching opportunities highlights our continued commitment to refining support mechanisms for our English learners.

In ELA and Math, efforts to stabilize staffing and implement new curriculums have seen varying degrees of success. The ELA team faced challenges with turnover and curriculum adjustments, while the Math team made strides in consistency and strategic tutoring, underscoring the nuanced challenges and successes across disciplines.

Recognizing the need for continuous improvement, there's a drive to enhance professional development focusing on EL strategies and revisiting grading rubrics to ensure they align with the strategic goals.

Overall, the successful implementation of the LCAP actions ensured a comprehensive and data-driven approach to supporting students, with a particular focus on English learners, underserved students, and different subgroups. The various interventions, support roles, and data analysis strategies put in place created a supportive and inclusive environment that fostered student success and growth.

There were no material differences between Budgeted Expenditures and Estimated Actual Expenditures

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

This LCAP was formulated during the initial stages of the COVID-19 pandemic, a period marked by unprecedented challenges including the shift to remote learning and the absence of authentic baseline data. Given the uncertain impact of the pandemic on students' academic progress and emotional well-being, our goals and targets were set against a backdrop of significant unknowns. Although we have observed growth in student outcomes, the extent of the pandemic's impact was initially unclear, affecting our ability to meet our three-year targets realistically in specific areas. This LCAP reflects our adaptability and commitment to student success in the face of such unpredictability, highlighting our ongoing efforts to address the evolving needs of our students during and beyond this global health crisis.

This is most evident in our CA School Dashboard academic desired outcomes. Based on our 2019 CA School Dashboard baseline data of Yellow for both ELA and Math, we set our 3-targets as "Green". While we have seen great progress toward getting back to a Yellow status and beyond, we did not meet our 3-year targets in ELA and Math. On the CA School Dashboard, our ELA and Math outcomes are as follows:

Math

- All: Orange 115.3 pts below
- EL: Orange 150.4 pts below
- SPED: 182.6
- Latino: Orange 116 pts below
- FRL: Orange 117.4 pts below

#### ELA

- All: Red 71.6 pts below
- EL: Red 105.4 pts below
- SPED: 165.2 pts below
- Latino: Red 73.1 pts below
- FRL: Red 77 pts below

Our data also reveals that our English Learners are underperforming in English Language Arts and Mathematics compared to other student groups. This disparity highlights the urgent need for targeted and intentional efforts to support our students with unique needs. Recognizing this, our new LCAP cycle will prioritize strategic interventions and tiered support mechanisms specifically designed to address the unique challenges faced by our English Learners.

We did not meet our GPA targets for 90% of students with a 2.0+ and and 40% of students 3.5+. Actions 2.5 and 2.6 were in support of our students reaching our GPA targets, yet vacancies due to mid-year departures of both Als and ATs presented challenges, though efforts to rehire and fill these positions have been underway.

The purchase of high-quality curriculum, blended learning, and technology purchases ensured that we effectively had 100% of students had access to standards-aligned instructional materials and internet and devices, for use at school and at home, while also scoring a 3.8 or higher on our implementation of state standards self-reflection tool.

We recognize that the current academic targets set were not fully met, necessitating significant revisions to our goals for the 2024-2027 cycle. These changes are rooted in a comprehensive analysis of our performance data, invaluable feedback from our educational partners,

and a critical review of the effectiveness of our existing strategies. Due to the challenges faced in meeting our predefined academic benchmarks, and recognizing the evolving needs of our student population, we have redesigned our goal structure to enhance focus and accountability.

The Actions and Metrics outlined in this current Goal 2 have evolved into two new goals for the new cycle. Our new Goal 1: Academic Growth for Significant Student Groups is specifically designed to ensure that all student groups demonstrate measurable growth towards meeting or exceeding standards in English Language Arts (ELA) and Mathematics. This shift comes in response to the identified need for targeted interventions and support for our significant student groups, specifically our English Learners, Socioeconomically Disadvantaged students, and Hispanic students who were Red in ELA on the 2023 CA School Dashboard. This new Goal 1 is focused on ensuring they receive the focused attention required to elevate their academic performance.

Our new Goal 2: Support growth and achievement for all students through strong instructional practices, informed by our assessment and data strategy is focused on recommitting to support growth and achievement for all students through robust instructional practices. This goal will be informed by an integrated assessment and data strategy that aims to optimize instructional methods and outcomes across all classrooms. This goal underscores our commitment to harnessing data-driven insights to refine teaching practices and enhance student learning experiences.

These changes stem from the observed opportunities of several actions within our current goals and are bolstered by feedback from our educational partners. The new goals are crafted to address specific areas that require intensified focus and innovation, ensuring that our strategies are not only reactive but also proactive in fostering an environment conducive to academic excellence and holistic development.

Our educational partners, including teachers, administrators, parents, and students, have played a critical role in shaping these new goals. Their insights into the practical aspects of educational delivery and the unique challenges faced by our student communities have been invaluable. Through regular consultations and feedback sessions, we have ensured that these goals are reflective of our collective aspirations and grounded in the realities of our educational landscape.

The strategic realignment of our LCAP goals for the 2024-2027 cycle represents a robust response to our previous shortcomings and a renewed commitment to academic excellence and student well-being. By focusing on specific student groups, strengthening instructional practices, and nurturing a supportive school environment, we are setting the stage for a comprehensive and inclusive educational experience that meets the diverse needs of our student population.

## **Goal Analysis**

The Actions outlined in Goal 5 have been successfully implemented to make progress toward our goal of increasing engagement for all of our families over the course of the 3-year LCAP. We were able to successfully develop and implement a community programming scope and sequence. To foster community engagement, we successfully held at least one community programming event per quarter, separate from regularly scheduled meetings such as SSC, ELAC, or Cafecitos. These events provided opportunities for families to come together and participate in school activities.

Cindy Avitia is actively evolving its cafecitos into a family member-led model, empowering families to take ownership and lead these sessions. This approach encourages greater involvement and participation from the parent community. To support families, we maintain services from the Alpha Parent Learning Center and Parent Leader Committee Lead. These resources provide educational support and connect families to various resources.

We continue to conduct parent leadership training meetings to empower families and equip them with the skills to advocate for their students. Collaborating with the Senior Director of Advocacy & Community Engagement, the school forms partnerships with external parties to bring additional services and resources to students and families. We also successfully maintained a parent engagement coordinator who plays a crucial role in improving overall family engagement. This position supports family meetings, volunteer opportunities, and ensures clear communication within the school community and other stakeholders.

Overall, these implemented actions demonstrate our commitment to creating a supportive and engaged community, fostering strong familyschool partnerships, and providing resources and opportunities for families to actively participate in their children's education.

There were no material differences between Budgeted Expenditures and Estimated Actual Expenditures.

Our Actions, as implemented during the 21-24 LCAP cycle, were effective in meeting and making progress toward our goal. We continued to strengthen our Parent Association, and we increased the number of events, clubs, and opportunities for family attendance on campus. Evidence of the effectiveness toward achieving our goal includes the following survey responses from our families:

- 90% of families feel welcome and heard by the school
- 90% of families feel the school does a good job of family engagement
- 88% of families agreed that the school listens to family voice and input when making decisions

The effects of COVID continue to impact our families and community, which has created the need to be more flexible and creative when we think about family engagement. We continue to offer opportunities both in person and over zoom, which has led to increased attendance at our parent meetings. Cafecitos and other formal meetings had lower attendance than pre-pandemic. We are continuing to strategize on practices we can implement to encourage an increased attendance at these meetings, including more frequent direct messaging from the principal.

For the 24-27 LCAP, this goal will be repositioned as Goal 4, however, will continue to remain focused on family engagement. While the focus remains the same, we will undergo a few changes to enhance parent partnership and development in order to best support student achievement and wellness. The new Goal 4 will be to "Build & cultivate community and family engagement to support student achievement & wellness". We've modified our actions to align to our family engagement vision at CAHS, which includes the elements of parent communication, school community events and celebrations, programs and services (Parent Learning Center), parent school partnerships, and parent power. This alignment ties to the California Community Schools Partnership Program (CCSPP) Implementation Grant that CAHS was awarded in May 2024, for the five year period from 2024-2029. A few key changes to the actions include:

- Parent School Partnerships: Highlight our focus on expanding parent volunteer opportunities to strengthen involvement of parents in their child's education experience
- Parent Power: Highlight our efforts to expand parent power at CAHS by providing parents with leadership opportunities to advocate for their students, including: School Site Council (SSC), English Language Advisory Committee (ELAC), Parent Leader Committee, and Alpha Parent Board Members

The introduction of an attendance committee marked a significant shift towards actively addressing attendance issues during our LCAP cycle. By integrating advisors into the process, allowing time for Tier 0 phone calls, and brainstorming incentive systems, the school demonstrated a proactive and inclusive approach to improving attendance. The involvement of school leaders, teachers, and staff in these initiatives underscores a community-wide commitment to student presence and engagement.

We continued to collaborate with FACTR for mental health counseling as we continue to see a larger number of students needing additional support following COVID 19. Recognizing the importance of mental health in academic success, the provision of counseling services is a critical support mechanism for students.

Despite the absence of a student government, the vibrancy of student clubs and fundraising activities highlights a robust student engagement framework. There is a strong desire among students to contribute to and partake in their school community.

The staffing stability, particularly with the Dean of Students and Operations Manager roles, contributed to a consistent and reliable administrative support system for students. This consistency was crucial for the effective implementation of policies and actions aimed at improving the school environment.

A significant challenge identified was the execution of Tier 0 phone calls, which are critical for early intervention in attendance issues. Allocating professional development time for making these calls was a strategic response to this challenge, although it also highlighted the need for more systemic solutions and the importance of diverse perspectives in tackling attendance.

The absence of a student government was noted as a missed opportunity for leadership and representation within the student body. Recognizing this gap, there's an identified opportunity to reintroduce student government in the following year's LCAP, suggesting a forward-looking approach to student engagement and governance

There were no material differences between Budgeted Expenditures and Estimated Actual Expenditures.

In evaluating the effectiveness of our actions towards meeting Goal 4 of our LCAP: Build a culture of increased empowerment amongst students by fostering a safe and supportive environment and supporting structures where students have authentic voice and input, we observe a mixture of results in our three-year targets, reflecting substantial achievements and areas needing further attention.

Family Survey Responses: Based on our Spring 2024 Family Survey, 92% of families agreed that our school facilities felt clean & welcoming, which is above our 90% target. In addition, we had an Exemplary facility ranking on our SARC, exceeding our goal. These outcomes highlight the effectiveness of Actions 6.6 (School Operations Accountability) and 6.9 (Facilities Improvements), which have been instrumental in enhancing the physical and communal aspects of our school environment.

Suspension Rate: 6.2 (Student Behavior Data via Deanslist), 6.3 (Partnership with FACTR), and 6.7 (Dean of Students) have been largely successful. We achieved our targets of 0% expulsion and maintained suspension rates under 5% as we have focused on cultivating a healthy & thriving school community.

Chronic Absenteeism: Similar to schools across California, CAHS experienced a significant spike in chronic absenteeism and a decline in ADA following the pandemic. While we fell below our original target (which was set based on pre-pandemic baseline data), we have seen growth in our preliminary 2023-2024 chronic absenteeism data overall. This points to the effectiveness of Action 6.1 (Maintain Effective Attendance Procedures). At the same time, we see many opportunities to continue to innovate our approach in improving absenteeism moving forward.

In summary, while we have successfully met many of our targets for creating a welcoming learning environment, the ongoing challenge of absenteeism and the need for continuous improvement in behavioral management highlight areas for ongoing focus and development. Our revised LCAP reflects a commitment to addressing these areas through targeted strategies and enhanced community engagement

In our ongoing efforts to refine and enhance our LCAP based on the current data available to us and input from our various educational partners, we have made strategic changes to the current Goal 4. In our new LCAP, this goal will be repositioned as Goal 3, reflecting a heightened focus on fostering a supportive and inclusive school environment. The new Goal 3 is articulated as: "Develop and cultivate a healthy and thriving school environment that promotes the safety and belonging of all students."

This shift in our LCAP is primarily driven by the trends identified in the CA School Dashboard and not meeting our current 3-year targets outlined in the current LCAP, particularly in Chronic Absenteeism and ADA. This data clearly indicates a need to intensify our efforts in addressing these areas to ensure that all students have the opportunity to thrive in a safe and supportive learning environment.

To address the identified issues and work towards substantial improvement, the following key shifts have been included in the new LCAP under Goal 3:

- Enhancing Attendance Systems: Recognizing the critical link between student attendance and academic success, we will implement a more robust attendance system. This system will leverage our Multi-Tiered System of Supports (MTSS) to provide targeted interventions and mitigation strategies, based on best practices outlined in the Alpha Attendance Playbook. These efforts are aimed at reducing chronic absenteeism by addressing its root causes and ensuring that all students have equal opportunities to succeed.
- Increasing Resources Toward Student Experiences: We plan to allocate more resources towards enriching student experiences both within and beyond the classroom. By enhancing engagement through diverse and meaningful activities, we aim to strengthen students' connection to the school, thereby reducing absenteeism and improving overall student morale.
- Implementing Restorative Justice Practices: We are committed to shifting from traditional disciplinary approaches to restorative
  practices that aim to repair harm and restore relationships. This approach encourages accountability, fosters understanding, and
  provides students with the tools to resolve conflicts constructively, which is crucial in reducing suspension rates and promoting a
  more inclusive school culture.
- Hiring Community Schools Staff: To further support our goal, additional staff will be hired under the community schools model. These professionals will focus on bridging school and community resources to provide comprehensive support for students and their families, addressing external factors that impact student attendance and behavior.
- Expanding Positive Behavioral Interventions and Supports (PBIS): We will continue to solidify and expand our PBIS framework, which has been instrumental in shaping positive behaviors across our schools. By strengthening this framework, we aim to further reduce disciplinary incidents and create a positive school climate conducive to student learning and growth.

The restructuring of our LCAP goals and the specific changes under the new Goal 3 reflect our proactive stance in responding to the critical

needs highlighted by our data. By prioritizing the development of a healthy and thriving school environment, we are taking decisive steps to ensure that our schools are places where all students feel safe, supported, and connected. These changes are not just about meeting metrics but are fundamentally about enhancing the educational experience and outcomes for every student we serve.

## **General Information**

Alpha: Cindy Avitia High School (CAHS) is part of the Alpha Public Schools network, whose mission is: We believe that all children have a fundamental right to an excellent education. Alpha Public Schools will ensure that all of our scholars develop the academic skills and leadership habits required to succeed in college and live with integrity.

Led by Principal Emma Karpowicz and a team of dedicated and skilled teachers, Alpha: Cindy Avitia High School (CAHS) prepares all students for college with the knowledge, skills, and self--discipline needed to succeed in college and beyond. Alpha supports families through every step of the college process to ensure students successfully apply to, enroll, and succeed throughout college. CAHS is a small, safe and tuition--free community school that opened its doors to its first class of 9th graders in the summer of 2015.

The school currently serves grades 9 to 12, and graduated its first class in 2018-19. CAHS students are primarily Latino and Vietnamese, and reside in East San Jose. CAHS serves approximately 428 students, 89% of which are socioeconomically disadvantaged. The school's demographic profile is 92% Latino, 4% Asian, 2% White, and less than 1% African American, Filipino, and Two or More Races. We serve a student body that is 48% English Learners and 17% Students with Disabilities (Source: DataQuest 2023-2024 Enrollment Reports). Many students will be the first in their families to attend college. The school is named in honor of Alpha's first board president, Cindy Avitia. Born and raised in East San Jose, Cindy served her community as an activist across many issues, a social and civil rights advocate, and an immigration attorney. Alpha is honored to memorialize Cindy, her commitment to empowering her community, and the spirit of service she embodied.

## **Reflections: Annual Performance**

With the release of the 2023 CA School Dashboard data, we are receiving performance colors for the first time since 2019. Alpha Public Schools continues to focus efforts on evaluating available state and local data to identify our LCAP areas of success and greatest areas of progress that inform the development of our LCAP Goals and Actions. Alpha Cindy Avitia is proud of our community of students, staff, parents and guardians that are focused and dedicated to ensure that each and every student thrives. While we continue to see the long-lasting impacts COVID-19 and distance learning is having on our student population, specifically in our chronic absenteeism rates, we have a lot to be proud of and celebrate. Some of the highlights as reported by the 2023 CA School Dashboard include:

English Learner Progress

• English Learner Students: 50.9% Making Progress (Green) compared to the state average of 48.7% (Yellow), which was a growth of 5.5% from the prior year.

Graduation Rates

- All Students: 87.6% (Green) compared to the state average of 86.4% (Orange), which was a growth of 2.7% from the prior year
- Hispanic Students: 86.7% (Green)

While we were encouraged by the strong EL Progress and Graduation Rate indicators on our 2023 CA School Dashboard, we have some performance gaps among our student groups compared to our overall results, as well as a Red status color in English Language Arts. Based on the 2023 CA School Dashboard, our performance gap data is as follows:

English Language Arts:

- All Students: 71.6 pts below standard (Red) compared to the state average of 13.6 pts below standard (Orange)
- English Learners: 105.4 pts below standard (Red)
- Hispanic Students: 73.1 pts below standard (Red)
- Socioeconomically Disadvantaged Students (SED): 77 pts below standard (Red)
- Students with Disabilities (SWD): 165.2 pts below standard (no performance color)

Graduation Rates:

• English Learners: 83.3% (Orange), compared to All Students (87.6%)

Our first goal is dedicated to enhancing support and achieving equity in educational attainment. Below is a comprehensive overview of the targeted actions under Goal 1: All student groups will demonstrate growth towards meeting or exceeding standards in English Language Arts (ELA) and Math designed to elevate student group outcomes:

• (Action 1.1) English Learner Supports: To enhance ELA and graduation outcomes for English learners, we are implementing a comprehensive support action that encompasses several key strategies: We will continue to employ an English Language

Development specialist to provide targeted instruction and support to teachers implementing integrated ELD, ensuring that English Learners receive the dedicated attention and resources they need to succeed. For Long-Term English Learners (LTELs), we are adopting the National Geographic Pathways Level 4 curriculum, designed to meet the complex needs of older ELs by enhancing their language proficiency and academic skills. This ongoing evaluation allows us to adjust instructional strategies dynamically, catering to the evolving educational needs of these students. Additionally, we are committed to providing continuous professional development for teachers, focusing on effective strategies for teaching LTELs. This includes training in culturally responsive teaching practices and advanced scaffolding techniques, which are critical for supporting the diverse cultural backgrounds and learning styles of English learners.

- (Action 1.2) High-Quality ELD Curriculum: Acquire and train staff in a high-quality ELD curriculum like EL Achieve, and employ assessments to monitor and refine the implementation of ELD curricula and ELA strategies.
- (Action 1.3) Students with Disabilities Supports: Create collaborative spaces for General and Special Education staff to focus on data-driven student accommodations and interventions in ELA and Math, using high-quality instructional materials.

Throughout our Local Control and Accountability Plan (LCAP) engagement process, we gathered invaluable feedback from our educational partners, which significantly shaped the specifics of our plan. Here's how we've incorporated this feedback into our LCAP:

#### Theme: Enrichment and Opportunities for Students

Educational partners expressed a strong desire for more enrichment and broader opportunities for students. In response, we have taken decisive actions under our newly established Goal 3: Develop and cultivate a healthy and thriving school environment that promotes the safety and belonging of all students:

- Action 3.6: Student Experiences We are committed to increasing the resources allocated to enhance non-academic student experiences, including student events, field trips, and student council activities. These initiatives aim to foster a vibrant community spirit and enrich students' school lives.
- Action 3.8: Expanded Learning Programs We continue to enhance our expanded learning offerings. By leveraging external partnerships and enhancing offerings in athletics and clubs, we provide students with diverse opportunities to learn and grow beyond the traditional classroom setting.

#### Theme: Support for Student Behavior

Feedback from our educational partners emphasized the need for additional support mechanisms addressing student behavior. To meet this need, we have introduced targeted actions:

- Action 3.3: Restorative Justice Practices We are incorporating restorative justice approaches to positively influence student behavior, promoting a culture of respect and mutual understanding.
- Action 3.1: Monitor & Respond to Student Culture & Behavioral Data We will maintain our Dean of Students to support multi-tiered intervention strategies. Additionally, tools like Dean's List and student culture surveys help us track behavior and culture data, allowing for targeted interventions.
- Action 3.10: Positive Behavioral Intervention and Support Systems Our plan solidifies and expands our PBIS framework, ensuring a supportive and inclusive school environment conducive to student learning and personal growth.

#### Theme: Supports for Struggling Students and Subgroups

A critical theme from our engagement process was the need for intensified support for struggling students and specific student groups. This led to the creation of student group focused Goal 1: Subgroup Focus: All student groups will demonstrate growth towards meeting or exceeding standards in English Language Arts (ELA) and Math. The following actions to support this goal and meet the needs of our educational partners include:

- Action 1.1 & 1.2: English Learner Supports and High-Quality ELD Curriculum These actions aim to enhance language acquisition and proficiency among English learners.
- Action 1.3: Students with Disabilities Supports We provide dedicated support to meet the unique needs of these students.
- Action 1.4: Academic Interventionists This action focuses on providing immediate academic support to students who are falling behind.

Theme: College and Career Readiness Family Development

In response to calls for more robust parent engagement, particularly in supporting college and career readiness, we have introduced two new actions under Goal 6:

- Action 6.5: College Success Program This program is designed to support our alumni through their college careers by providing
  essential resources to navigate post-secondary education. We have committed to staffing college mentors and alumni advisors who
  will assist in locating and utilizing necessary resources, ensuring our alumni continue to succeed beyond our school.
- Action 6.6: Comprehensive College Readiness Support We are offering comprehensive workshops and counseling sessions for students and families focused on financial aid, scholarships, and grants, including assistance with FAFSA completion.

Additionally, we support the college application process by helping with college selection, application completion, essay writing, and meeting application deadlines. This action aims to empower families and students in making informed decisions about higher education, thereby enhancing their preparedness for future academic and career opportunities.

Finally, as part of our strategic actions under Goal 4, and to deepen family and community engagement, CAHS has been awarded a Community Schools Partnership Program Implementation Grant. Efforts in support of CCSPP are in part outlined in our new Goal 4, with an emphasis on Action 4.5: Parent Power, which focuses on developing leadership opportunities for parents to actively participate and advocate within the school community. Leadership roles include:

- School Site Council (SSC)
- English Language Advisory Committee (ELAC)
- Parent Leader Committee (Advocacy)
- Alpha Parent Board Members

Each of these themes and the corresponding actions are deeply rooted in the feedback from our educational partners. Their insights have been instrumental in shaping a responsive and dynamic LCAP, ensuring that we address the diverse needs of all students while fostering an environment that supports academic success and personal development.

The rationale for establishing the academic goal focused on our subgroups, particularly in English Language Arts (ELA) and Math, is grounded in our commitment to equity and the urgent need to address the educational disparities exacerbated by the pandemic. The pandemic's impact on education has been profound and uneven, with our subgroups, English Learners, Students with Disabilities, Socioeconomically Disadvantaged students, and Hispanic students, facing significant challenges that have resulted in disproportionate outcomes compared to their peers. As a result, on the 2023 CA Dashboard in ELA, our EL, SED, and Hispanic subgroups had a performance color of Red in ELA and Orange in Math.

Of note, in ELPI, our English Learners had a 50.9% progress rate and were Green on the CA School Dashboard.

Our decision to prioritize this goal is in direct response to feedback from our educational partners, including teachers, staff, and parents, who have consistently emphasized the necessity of improving academic outcomes for these subgroups. The collective insights gathered through the LCAP engagement process highlighted a shared understanding that targeted efforts are needed to ensure all students have equitable opportunities to succeed.

To address these disparities, we are committed to implementing comprehensive strategies that include enhancing our Tier 1 instructional practices to ensure a strong foundation of quality teaching and learning for all students. We recognize the importance of specialized intervention programs that provide additional support to students who are not meeting standards. Our approach includes strengthening English Language Development (ELD) support to better assist English Learners in achieving proficiency in ELA, and enhancing academic and behavioral supports for students with special education needs. These targeted interventions are designed to address the specific learning gaps and challenges faced by these students.

Our commitment to this goal is data-driven, relying on comprehensive analysis to identify the areas of greatest need and to monitor the effectiveness of our interventions. Through continuous assessment and reflection, we will adapt our strategies to ensure they are meeting the intended objectives and making a measurable impact on student outcomes.

However, given the teacher shortage that we are experiencing in the Bay Area, it has grown increasingly competitive to hire and retain strong educators for our school. To address this, we have established the following theory of change at Alpha: If we develop excellent coaches, then they will develop excellent educators, which will result in improved student outcomes. Therefore, we are focused on continuing to invest heavily in internal and external professional development and coaching of our leaders, teachers, and instructional staff. We are creating leadership pathways for staff members to grow and stay at Alpha, we regularly review our compensation and benefits packages, and we are using a variety of recruitment strategies to attract high-quality talent to CAHS.

All of stakeholder groups, through the LCAP / initiative setting process, highlighted the need to continue this goal into our next 3-year cycle, which emphasizes the importance of hiring, developing, and retaining high quality faculty and staff as a key enabler in our success in achieving all of our other goals.
